#### Evaluation of Programme Outcomes (POs) and Course Outcomes (COs) at GJIMT

At Gian Jyoti Institute of Management and Technology (GJIMT), the systematic evaluation of Programme Outcomes (POs) and Course Outcomes (COs) is designed to measure student achievement effectively and to ensure that learning objectives are met, fostering continuous improvement in the educational process.

#### **Evaluation Methodology**

The attainment of POs and COs at GJIMT is assessed primarily through students' academic performance in each course. Each subject is governed by a clearly defined attainment framework, with internal assessments and end-semester examinations contributing to the overall evaluation. The assessment is broken down as follows: internal assessment accounts for 40 marks, while the end-semester examination contributes 60 marks, totaling 100 marks per subject.

The performance thresholds are categorized into three levels of attainment:

Level	Attainment	Score Range
Level 3	High Attainment	Above 60%
Level 2	Medium Attainment	Between 50-60%
Level 1	Low Attainment	Between 40-50%

For each subject, students are expected to achieve a minimum of 60% to meet the attainment threshold. This ensures that they have grasped the core concepts and skills required for success in their respective fields.

#### Assessment Levels

At the end of each semester, the attainment levels for each subject are determined based on the distribution of students' scores. The overall attainment for a class is classified using the following criteria:



Level	Attainment Criteria	Percentage of Students Scoring Above 60%
Level 3	Level 3 Attained	More than 60%
Level 2	Level 2 Attained	50-60%
Level 1	Level 1 Attained	40-50%

This structured evaluation framework provides a clear picture of students' performance, highlighting strengths and identifying areas for improvement. It also allows for a systematic assessment of whether the learning outcomes have been achieved.

#### **Implementation and Review**

Faculty members at GJIMT are responsible for conducting the evaluation of POs and COs at the end of each semester. The process involves several key steps:

- 1. **Data Collection:** Gathering students' scores from continuous assessments and end-semester exams.
- 2. Analysis: Calculating the percentage of students achieving each attainment level.
- 3. **Evaluation:** Determining the overall attainment level for each subject based on the established criteria.
- 4. **Reporting:** Compiling and reporting the results to GJIMT's academic affairs committee.

The academic affairs committee reviews these evaluation reports and provides feedback to the faculty. This feedback is essential for identifying best practices and areas that need attention. The insights gained from this evaluation process are used to enhance teaching methods, curriculum design, and assessment strategies, ensuring that the educational programs continue to meet high standards of quality and relevance.
